VISA INFORMATION

- ❖ Citizens of the following countries DO NOT need a visa and can enter Bosnia and Herzegovina using **ONLY THEIR ID**:
Austria, Belgium, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Latvia, Lithuania, Luxembourg, Malta, Montenegro, Netherlands, Norway, Poland, Portugal, Romania, Serbia, Slovakia, Slovenia, Spain, Sweden, Switzerland.
- ❖ Citizens of the following countries DO NOT need a visa and can enter Bosnia and Herzegovina using a **VALID PASSPORT** (should be valid for at least 3 months after exiting the country):
Argentina, Australia, Brasil, Canada, Chile, China, China - Hong Kong, China - Macao, Colombia, Israel, Japan, Kuwait, Mexico, New Zealand, Nicaragua, North Macedonia, Oman, Panama, Peru, Qatar, Russia*, South Korea, Turkey, Ukraine**, United Arab Emirates, United Kingdom, United States of America.

*maximum of 30 days within a 60 day period after the first entry

**maximum of 30 days within 2 months after the first entry

IF YOU ARE NOT A CITIZEN BUT HAVE A RESIDENCE PERMIT OR A VISA FOR ANY OF THE EU STATES, SCHENGEN COUNTRIES OR THE UNITED STATES OF AMERICA, YOU CAN STAY IN BOSNIA AND HERZEGOVINA FOR A MAXIMUM OF 30 DAYS WITHOUT A VISA.

CITIZENS OF ALL OTHER COUNTRIES NEED A VISA to enter Bosnia. As it can be a lengthy process (sometimes even three months!), it is necessary to nominate as soon as possible, to avoid having to reschedule the traineeship and other unwanted events.
